



Howard Johnson – Castaway Cove Rules

To ensure the safest experience for all guests during their visit, the following rules are in effect. We appreciate your cooperation in this regard.

1. Castaway Cove (CAC) is for the exclusive use of registered Hotel Guests.
2. A wristband is REQUIRED for entrance for both Adult and Child Hotel Guests. MUST BE WORN AT ALL TIMES! The only time this is excused is special pretenses given to Lifeguards by the FRONT DESK staff.
3. Howard Johnson is a smoke free environment. Smoking is permitted outside of the water park in the designated location by the “Howard Johnson” organ chair. Please see Lifeguard for information.
4. Children under 16 must ALWAYS be supervised by an adult (18 years or older)
5. Persons having currently active diarrhea or have had active diarrhea within the past 14 days shall not be allowed to enter the water
6. Lounge chairs are available on a first come first served basis. Lifeguard will assign you seating based on party size and availability. Lounge chairs must remain in designated areas and are not to be moved. Please see lifeguard before moving to a different seating.
7. 3-hour time limit upon entry into the facility (during busy hours / seasons).
8. Guests are permitted to wear their own lifejacket; however, it must be Coast Guard certified. All lifejackets are not allowed to be worn while riding the slides.
9. Children at wading pool need to be accompanied by an adult and be within arm’s reach.
10. Diapered children must wear approved, reusable, plastic swim pants in all pools and attractions. Please change diapers / swimwear in restrooms. See Lifeguard for details.
11. Proper swimwear is required. Swimwear is defined as a one- or two-piece swimsuit. Pants, denim, thongs, or transparent clothing are not permitted. No metal ornamentation on clothing. We reserve the right to determine the appropriateness of swimwear.
12. Guests wearing bathing attire with metal buttons, rivets, zippers, or snaps will not be permitted to ride the slides
13. Aqua socks and aquatic style footwear are permitted.
14. Climbing slides is not allowed





15. No running, diving, extended breath holding, boisterous or rough play at the aquatic facility.
16. No climbing, swinging, or hanging on rails in the pool and the perimeter fencing
17. Climbing slides is not allowed. Children must go down the waterslide(s) feet first, seated on their bottoms.
18. Maximum operation load is **1 person, 200lbs** (90.9 KG).
19. Person under 36 inches (1.07M) Tall are not permitted on large slide (green one).
20. One rider to enter the flume at a time. Single riders ONLY!
21. Eyeglasses must be securely affixed to riders with head strap.
22. Slide must be ridden feet first lying on your back with firmly crossed at the ankles and arms folded across the chest (to prevent)
23. Riders must wait for the attendants start signal before starting the ride.
24. Do not uncross your legs or attempt to sit up until you have come to a stop in the shutdown lane.
25. Do not run, dive, stand, kneel, rotate, or stop on/in the slide.
26. At the end of the slide, obey all instructions by attendants exit quickly.
27. Glass items are not permitted in the aquatic facility. Please see lifeguard for options.
28. No food or drink while using or inside aquatic features.
29. Connect-4 and other poolside games must not be put into the aquatic attractions or submerged in water to prevent damage.
30. Service animals are permitted into the waterpark but are not permitted in water attractions.
31. To provide a safe and enjoyable waterpark experience for our guests, Premier Aquatics utilizes training exercises to improve our lifeguards' skills and vigilance. These exercises will occur during normal operating hours and may consist of the following: submersible manikins, the use of video surveillance equipment, internal and external audits, active/inactive water rescues and/or first aid scenarios.
32. Our lifeguards are highly trained and qualified. Always follow their instructions. Do not talk to or distract lifeguards while they are on duty.
33. Some attractions may be on a rotation basis and/or may be closed at any time, without notice at the discretion of park management.



34. No person shall knowingly possess, have under the person's control, convey, or attempt to convey a deadly weapon or dangerous ordnance onto these premises.

Caution: For safety reasons, pregnant women, elderly persons with heart conditions or back troubles should not ride the slides.



Howard Johnson -Hot Tub Rules

To ensure the safest experience for all guests during their visit, the following rules are in effect. We appreciate your cooperation in this regard.

1. Castaway Cove - Hot tub is for the exclusive use of registered Hotel Guests.
2. A wristband is REQUIRED for entrance for both Adult and Child Hotel Guests. MUST BE WORN AT ALL TIMES! The only time this is excused is special pretenses given to Lifeguards by the FRONT DESK staff.
3. Howard Johnson is a smoke free environment. Smoking is permitted outside of the Water Park and in the designated location by the "Howard Johnson" orange chair. Please see Lifeguard for information.
4. Persons having currently active diarrhea or who have had active diarrhea within the past 14 days shall not be allowed to enter the water.
5. Lounge chairs are available on a first come, first serve basis. Lifeguard will assign you seating based on party size and availability. Lounge chairs must remain in designated areas and are not to be moved. Please see lifeguard before moving to different seating.
6. 3-hour time limit upon entry into the facility (during busy hours/seasons).
7. Children under 16 must ALWAYS be supervised by an adult (18 years or older).
8. Children under 14 must be supervised by a parent or adult in the Hot Tub.
 - a. Parent/ adult being 18+ years old.
 - b. Parent / Guardian should be inside the hot tub or feet in the hot tub.
 - i. Rule of Thumb; parents should be within arm's reach of their child.
 - c. We advise infants and toddlers should NOT be in the hot tub.
9. Diapered children must wear approved, reusable, Plastic swim pants in all pools and attractions. Please change diapers / swimwear in restrooms. See Lifeguard for details.
10. Proper swimwear is required. Swimwear is defined as a one- or two-piece swimsuit. Pants, denim, thongs, or transparent clothing are not permitted. No metal ornamentation on clothing. We reserve the right to determine the appropriateness of swimwear.





11. Guests wearing bathing attire with metal buttons, rivets, zippers, or snaps will not be permitted to ride slides.
12. Aqua socks and aquatic style footwear are permitted.
13. Guests are permitted to wear their own life jacket; however, it must be Coast Guard certified.
14. Glass items are not permitted in the aquatic facility. Please see lifeguard for options.
15. No food or drink while using or inside hot tub.
16. No running, diving, extended breath holding, boisterous or rough play at the aquatic facility; walk-in entry ONLY.
17. No swimming, full body submersion, and physical exertion in the hot tub.
18. No rafts in the Hot Tub. This includes "inflatable donuts/rafts."
19. No climbing, swinging, or hanging on rails in the hot tub and the perimeter fencing.
20. Service animals are permitted in the waterpark but are not permitted in water attractions.
21. To provide a safe and enjoyable waterpark experience for our guests, Premier Aquatics utilizes training exercises to improve our lifeguards' skills and vigilance. These exercises will occur during normal operating hours and may consist of the following: submersible water manikins, the use of video surveillance equipment, internal and external audits, active/inactive water rescues and/or first aid scenarios.
22. Our lifeguards are highly trained and qualified. Always follow their instructions. Do not talk to or distract lifeguards while they are on duty.
23. Aquatics staff and lifeguards reserve the right to impose the use of lifejackets as needed.
24. Some attractions may be on a rotation basis and/or may be closed at any time, without notice at the discretion of park management.
25. No person shall knowingly possess, have under the person's control, convey or attempt to convey a deadly weapon or dangerous ordnance onto these premises.
26. Max occupancy: 15 persons

Caution: For safety reasons, pregnant women, elderly persons with heart conditions, infants/children or persons under the influence should not enter the hot tub. Long exposure may cause nausea, dizziness, and fainting.





Howard Johnson – Garden Pool Rules

To ensure the safest experience for all guests during their visit, the following rules are in effect. We appreciate your cooperation in this regard

1. Garden Pool (GP) is for the exclusive use of registered Hotel Guests.
2. A wristband is REQUIRED for entrance for both Adult and Child Hotel Guests. **MUST BE WORN AT ALL TIMES!** The only time this is excused is special pretenses given to lifeguards by the FRONT DESK staff.
3. Howard Johnson is a smoke free environment. Smoking is permitted outside of the Water Park and in the designated location by the “Howard Johnson” Orange Chair. Please see Lifeguard for information.
4. Children under 16 must ALWAYS be supervised by an adult (18 years or older).
 - a. Rule of thumb: parents should be within arm’s reach of their child.
5. Persons having currently active diarrhea or who have had active diarrhea within the past 14 days shall not be allowed to enter the water.
6. Lounge chairs are available on a first come first served basis. Lifeguard will assign you seating based on party size and availability. Lounge chairs must remain in designated areas and are not to be moved. Please see lifeguard before moving to different seating.
7. 3-hour time limit upon entry into the facility (during busy hours / seasons).
8. Diapered children must wear approved reusable, plastic swim pants in all pools and attractions. See attendant for details.
9. Proper swimwear is required. Swimwear is defined as a one-or two-piece swimsuit. Pants, denim, thongs, or transparent clothing are not permitted. No metal ornamentation on clothing. We reserve the right to determine the appropriateness of swimwear.
10. Aqua socks and aquatic style footwear are permitted.
11. Life jackets are available for use at Garden Pool. Life jackets are complimentary and are available to any guest wishing to use one. Children, first-time swimmers, and weaker





swimmers are encouraged to wear a life jacket. Lifeguard for details and to check out a jacket.

- a. Guests are permitted to wear their own life jacket; however, it must be Coast Guard certified.
12. No running, diving, extended breath holding, boisterous or rough play at the aquatic facility.
13. No climbing, swinging, or hanging on rails in the pool and the perimeter fencing.
14. Glass items are not permitted in the aquatic facility. Please see lifeguard for options.
15. No food or drink while using or inside pool.
16. Service animals are permitted into the aquatic facility but are not permitted in the water.
